Diversified in energy, agronomy, grains and foods, CHS is committed to creating connections to empower agriculture, helping its farmer-owners, customers and other stakeholders grow their businesses through its domestic and global operations. CHS supplies energy, crop nutrients, seed, crop protection products, grain marketing services, production and agricultural services, animal nutrition products, foods and food ingredients, and risk management services. The company operates petroleum refineries and pipelines and manufactures, markets and distributes Cenex* brand refined fuels, lubricants, propane and renewable energy products. Our preferred stock trades on the NASDAQ exchange under CHSCP, CHSCO, CHSCN, CHSCM and CHSCL.

- Employs more than 5,000 people and helps build vibrant communities through volunteerism and stewardship efforts including CHS Harvest for Hunger.

Energy

Petroleum, refining and pipelines

- Owns refineries at Laurel, Montana, and McPherson, Kansas, with a combined 175,000-barrels-per-day processing capacity.
- Accesses crude oil for our refineries and move product to the marketplace through more than 2,000 miles of pipeline.
- Provides a dependable supply through 400 million gallons of storage at CHS refineries and 23 CHS-owned product terminals.

Energy products

- Supplies more than 3 billion gallons of refined fuels annually, including gasoline and diesel.
- Oversees a network of more than 1,450 Cenex® retail outlets, including more than 1,000 Cenex convenience stores, among them more than 40 CHS-owned Cenex Zip Trip® locations.
- Ranks as one of the nation's largest propane wholesalers, helping to supply retail customers with a safe, year-round supply of propane via robust transportation and storage systems, leading to efficient supply chain management.
- Keeps agricultural, industrial machinery and over-the-road trucks, passenger vehicles and recreational equipment running smoothly with high-quality, heavy-duty lubricants.

Renewable energy

 One of the largest U.S. marketers of ethanol products, a leading marketer of biodieselblended fuels and a growing participant in global renewable fuels imports and exports.

- Operates two ethanol plants in Rochelle, Illinois, and Annawan, Illinois (each at 130 million gallons per year), which produce 710,000 tons of distiller's dried grains with solubles (DDGS) annually.
- Has more than four decades of experience as a leading marketer of renewable fuels, providing a critical link between grain farmers, ethanol manufacturers and blenders of biofuels.
- Manufactures vegetable oil-based, environmentally friendly lubricants.

Transportation and logistics

 Operates one of the nation's largest private truck fleets, logging nearly 35 million miles annually, with specialized equipment serving the needs of North America's businesses.

Global grain and processing

We market more than 2 billion bushels of grains and oilseeds (52 million metric tons) annually to domestic and export customers in more than 65 countries.

CHS North America

Grain marketing offices in the United States and Mexico.

Grain and oilseeds

- Have an extensive grain origination network and source and market grains and oilseeds from member cooperatives, CHS-owned facilities and farmers.
- Markets DDGS, a byproduct of ethanol manufacturing used by the livestock feed industry.

Grain and oilseeds, continued

- Operates terminals on the Mississippi, Minnesota, Ohio and Illinois rivers.
- Moves grains, oilseeds and DDGS to global customers through strategic export terminals at Myrtle Grove, Louisiana, and Superior, Wisconsin, through the TEMCO joint-venture facilities at Tacoma and Kalama, Washington, and Portland, Oregon, and through a terminal through-put agreement at Houston, Texas.
- Supplies domestic wheat millers, feed manufacturers, high-volume feed grain users and other customers with grain, oilseeds and DDGS and meet the needs of regional cattle, dairy and poultry producers.

CHS South America

Brazil: With headquarters in São Paulo and locations throughout Brazil, CHS originates grain and distributes fertilizers throughout the main agricultural areas. Products move through major ports in the region.

- Imports fertilizer and blends into formulas for use by farmers in the region.
- Exports grain through ownership of TCN, a joint venture company with terminal access at the Port of Itaqui, São Luís, as well as through main export corridors including Santos and Paranaguá.
- Operates fertilizer import, storage and blending services through a joint-venture company, Andali, at Rondonópolis, Brazil.
- To help ensure supply for corn and soybean customers year-round, CHS added a transshipment asset in Marialva, Brazil, establishing another integral link in the company's global supply chain.

Argentina, Paraguay, Uruguay: With headquarters in Buenos Aires and operations in three countries, CHS originates grain and distributes fertilizers throughout main agricultural regions. Products move through major ports in the region.

- Exports grain through joint-venture ownership in port Sitio O, as well as through main export corridors in the three countries.

CHS Asia Pacific

Based in Singapore with offices in Australia, China, South Korea and Taiwan. Serves Pacific Rim customers by receiving grains, DDGS and fertilizer from CHS global origination points.

- Operates import and distribution facility at Nantong, China.
- Serves markets through CHS Broadbent, a joint marketing venture between CHS and Broadbent, based in Ballarat, Victoria, Australia, with a focus on grain origination, logistics and domestic and export trade.
- Owns facilities in Australia including container packing at Toowoomba, Queensland, and Ballarat, Victoria, along with bulk storage at Jondaryan, Queensland, Moree, New South Wales, and Lakaput and Lake Bolac, Victoria.

CHS Europe

Based in Geneva, Switzerland, with offices in Bulgaria, Hungary, Romania, Serbia, Spain and Ukraine, along with Jordan and Turkey in the Middle East, to source and market grains and oilseeds from the Black Sea and Mediterranean Basin regions and to coordinate global fertilizer sourcing.

- Owns strategically located facilities including barge loading at Giurgiu, Romania, on the Danube River, and Oroshaza, Hungary.
- Access to Black Sea through deep-water ports at Odessa, Ukraine, and Constanta, Romania, and through other export terminals in Yuzhny and Nikolayev, Ukraine.

Animal nutrition

- Provides livestock producers with quality feeds under the CHS Payback® and CHS Equis® brands.
- Owns half of Consumers Supply Distributing, LLC, based in Sioux City, lowa, providing wholesale and retail customers with a variety of agricultural and animal nutrition products including Running Horse® equine feed, Rancher's Choice® low-moisture protein tubs, pressed blocks and Country Vet® pet foods and treats.

Soybeans

CHS products include refined and crude soybean oil; soybean meal, defatted soy white flake and defatted Honeysoy® flour. CHS:

- Refines more than 1.7 billion pounds (590,000 metric tons) of soybean oil annually.
- Processes more than 100 million bushels (2.7 million metric tons) of soybeans annually, the equivalent of 2 million acres.
- Produces 2.5 million tons (2.25 million metric tons) of soy protein products for global and domestic use in human and animal foods.

Canola

Operates a canola processing and refining plant near Hallock, Minnesota:

- Processes 475,000 metric tons of canola seed annually.
- Produces 39.6 million pounds of canola oil annually.
- Produces 250,000 metric tons of canola meal annually.

CHS Sunflower

- Supplies ingredients to nationally known snack brands, serving more than one-third of the domestic kernel and in-shell market.
 We also export sunflower products to Europe, the Middle East and the Pacific Rim.
- Markets and develops our own Royal Hybrid sunflower planting seeds, which are grown domestically and internationally.

Wheat flour milling

 Supplies durum wheat to our partner and North America's leading flour miller, Ardent Mills, LLC, which produces flour products for bakeries, food manufacturers and other customers. It serves the consumer marketplace through 40 flour mills, three bakery-mix facilities and specialty bakeries in the United States and Canada.

Food products

 Reaches consumer tables across the United States with vegetable-oil-based foodservice and retail products produced by Ventura Foods, LLC, a joint-venture company that is the nation's leading manufacturer and marketer of branded and custom-made shortenings, oils, dressings, sauces, mayonnaise, margarines, culinary bases and pan coatings.

Agronomy

Crop inputs

- Owns and operates more than 30 wholesale distribution centers for crop nutrients, crop protection and other specialized crop inputs.
- Supplies agronomy products and services through owned or leased fertilizer terminals, strategic joint ventures with member cooperatives and an industry-leading network of cooperatives and retailers.
- Offers proprietary crop protection and crop nutrition products, including Trivar® and N-Edge®, which enhance fertilizer efficiency.
- Leverages a global fertilizer supply chain, including domestic production, a deep-water port in Galveston, Texas, and a line of high-performance river terminals throughout the Mississippi and Ohio river systems.
- Produces 1.7 million tons of nitrogen fertilizers through a strategic venture with CF Nitrogen to ensure long-term dependable fertilizer supply for cooperatives.

Stewardship

CHS is committed to extending the positive impact of the cooperative system to make a meaningful difference. The CHS Foundation focuses on developing ag leaders for life, and CHS Community Giving aims to strengthen hometown communities.

- The CHS Foundation, which is celebrating its 75th anniversary in 2022, advances innovation in cooperative education, cultivates opportunity through university partnerships, grows high-impact youth leadership programs and accelerates the potential for careers in ag.
- CHS Community Giving strengthens communities through promoting ag health and safety, supporting communities with cooperative matching grants, and advancing the CHS culture of service.
- CHS employees receive paid time off to volunteer to support local causes. During CHS Spirit of Service Days in June 2022, employees from two countries and nine states volunteered more than 1,200 hours in 30 communities. In addition, the national Harvest for Hunger food drive has connected CHS employees, customers and partners to raise more than \$7.37 million and nearly 3.94 million pounds of food since 2011.
